Installation: Mount the tubular daylight device (TDD) to a wood curb. Use a minimum 2x Spruce-Pine-Fir dimension lumber wood curb. Design the wood curb and the attachment of the wood curb to the roof framing to resist the design pressures of the skylight assembly as specified in this evaluation report. Design of the wood curb and the attachment of the wood curb to the roof framing must be done by a Texas licensed engineer.

Secure the skylight assembly to the wood curb using the curb flashing with minimum No. 10 x 2" Phillips truss head screws. Locate the fasteners along each side of the assembly spaced approximately 12" from each corner and 27-3/4" on center. Fasteners must be long enough to penetrate a minimum of 1-1/2" into the wood framing.

Note: Keep the manufacturer's installation instructions available on the job site during installation. Use corrosion resistant fasteners as specified in the IRC and the IBC.
